## GENERAL RULES

### GENERAL RULES

1. This flower show conforms to the standards established by National Garden Clubs, Inc. (NGC). The *Handbook for Flower Shows*, (HB) 2017 Edition with revisions published in *The National Gardener* magazine (TNG) is the authority for all issues not covered by the Schedule, which is the Law of the Show.
2. Entries are **open to all amateur gardeners and designers**.
3. All entries will be received Wednesday, October 19, 2022, between **8:00 and 11:00 a.m.** All exhibits must be in place and all exhibitors off the floor by 11:00 a.m.
4. Pre-registration required for Division II, Classes 1-10; and Division III, Classes 2-6. Designs should be ready to be placed, not constructed on site. Designers not present by 10:45 a.m. will be considered “NO SHOWS” and their exhibits excluded from judging.
5. All entries must be removed Sunday, October 30, beginning at **8:00 a.m.** Designs **MUST** be removed on Sunday, October 30, by **NOON**; however, if the design is not picked up by 11:00 a.m., the committee will move it to a safe place so that clean-up can be completed.
6. Design Entry Cards are filled out in advance by committee. Horticulture Entry Tags may be obtained from show Chairman upon request. Exhibitor to fill in with pencil the date, common name, exhibitor’s name and garden club with assistance in plant identification from Classification (labels may be used on all copies).
7. **Judging will begin at 1:00 p.m. on Wednesday, October 19.**
8. All **horticulture exhibits must be approved** by the Classification Committee. This committee may disqualify any entry not conforming to the schedule, or which cannot be made to conform, or any entry which is of inferior quality; however, these may be displayed for educational purposes.
9. The Show Chairman and the Classification Team for each division are available during judging for possible consultations. They, along with the judges and clerks, are the only personnel allowed on the floor during judging.
10. The decisions of the judges are final. Awards may be withheld if not merited.
11. There must be emphasis on FRESH plant material. No artificial plant material is permitted in any exhibit in any division.
12. Each exhibitor is limited to one entry per class, except in the Horticulture Division and the Botanical Arts Horticulture Section.
13. Specific rules are listed with each Division in the schedule and must be followed.
14. The Pensacola Federation of Garden Clubs, Inc., and the Pensacola Interstate Fair, Inc., will strive to assure the safety of all items after arrival and placement, but are not responsible for any loss or damage to exhibits.
15. Native plants may be entered provided such plants have been legally obtained and grown by the exhibitor for at least 90 days. The use of plant material classified as Federal Noxious Weeds is prohibited ([aphis.usda.gov](http://aphis.usda.gov)). The use of plant material on Florida’s Federally Listed Plant Species as endangered or threatened is prohibited ([fdacs.gov](http://fdacs.gov)). The use of invasive plant material is prohibited ([floridainvasivespecies.org](http://floridainvasivespecies.org)).
16. **The show will be open to the public at 4:00 p.m. when the Fair opens on Thursday, October 20.** The date October 19 is being used in this schedule as the day for submitting entries and judging.

## GENERAL RULES

### NGC TOP EXHIBITOR AWARDS

The NGC Standard System of Awarding is used in all divisions.

- a. Only one (1) first place (blue) ribbon per class or subclass, scoring 90 or above;
  - b. Only one (1) second place (red) ribbon per class or subclass, scoring 85 or above;
  - c. Only one (1) third place (yellow) ribbon per class or subclass, scoring 80 or above;
  - d. One (1) or more honorable mention (white) ribbons as merited, scoring 75 or above.
- Top Exhibitor Awards listed may be offered and awarded if merited.

### REQUIREMENTS FOR NGC HORTICULTURE DIVISION TOP EXHIBITOR AWARDS

1. All plant material must be cut or container grown.
2. Exhibit must be a blue-ribbon winner scoring 95 or more points. Eligible horticulture exhibits will be placed on the Awards table.
3. Exhibit must be correctly named with genus and specific epithet, cultivar/variety if available; common name may be added.
4. Plant material must in possession of the individual exhibitor for the required length of time.
5. There must be at least three classes in each designated section. There is no minimum number of exhibits per class required except that total number must meet requirements for a Standard Flower Show (at least 20 horticulture exhibits in all).
6. Sections/classes eligible for each award must be listed in the schedule.
7. An award must be withheld if no exhibit is worthy and/or fails to meet specific requirements for the award.

### HORTICULTURE DIVISION AWARDS

1. **Award of Horticultural Excellence (HB p. 40)** may be offered and awarded to the correctly named, highest scoring blue ribbon exhibit earning 95+ in the entire Horticulture Division. The winning exhibit will also have won another Top Exhibitor Award in the Horticulture Division. Only winners of Awards of Merit, Arboreal Awards, Grower's Choice, Collections, Displays, or the Rose Award are eligible for the Award of Horticultural Excellence. It is a rosette of green, orange, and blue ribbons.
2. **Awards of Merit (HB p.41)** are Section Awards for all cut non-woody specimens, including vines and fruits, vegetables, and nuts, offered and awarded to the correctly named, highest scoring blue ribbon exhibit earning 95+ in each section. All general Horticulture Award requirements must be met. It is a rosette of orange ribbons.
3. **Arboreal Awards (HB p.40-41)** are available to sections for Cut Flowering Branches, Cut Foliage Branches, and Cut Fruited, Coned, or Berried Branches. These awards may be offered and awarded to the highest scoring exhibits earning 95+ in these sections if eligible sections/classes are designated in the schedule and all other General and Horticulture Award Requirements have been met. It is a rosette of green ribbons.
4. **Grower's Choice Awards (HB p.41)** are Section Awards for Container-grown Flowering Plants, Container-grown Foliage Plants, and Hanging Baskets. They may be offered and awarded to the highest scoring exhibits earning 95+ if eligible sections/classes are designated in the schedule and all other General and Horticulture Award Requirements have been met. It is a rosette of dark green ribbons.

## GENERAL RULES

5. **Collector's Showcase Award - Collections (HB p.41, p.60)** is a Section Award and is offered and may be awarded to the highest scoring collection of five (5) or more different specimens (cut and/or container grown) exhibited in individual containers, or the appearance of being individually exhibited for their cultural perfection. Specimens must be related. Each specimen within the exhibit must score 95 points or more. This award is being offered in the Collections Section. It is a rosette of brown and green ribbons.
6. **Collector's Showcase Award - Displays (HB p. 41, p.60)** is a Section Award and is offered and may be awarded to the highest scoring display of five (5) or more different specimens (cut and/or container grown) exhibited in individual containers, or the appearance of being individually exhibited for overall artistic effect. Specimens must be related. Each specimen within the exhibit must score 95 points or more. This award is being offered in the Display Section. It is a rosette of brown and green ribbons.

### REQUIREMENTS FOR NGC DESIGN DIVISION TOP EXHIBITOR AWARDS

1. Exhibit must be a blue-ribbon winner scoring 95 or more.
2. Schedule must designate award's special requirements, classes eligible, and number of exhibits required per class.
3. There must be a minimum of three classes with at least four exhibits in each class (twelve designs) for each award offered.
4. No section can be eligible for more than one Top Exhibitor Design Award.
5. All general and design award requirements must be met for each award offered. Judges must withhold award if no exhibit meets the requirements. Club Competition is not eligible for these awards.

### DESIGN DIVISION AWARDS

1. **Designer's Choice Award (HB p. 42)** may be offered and awarded to the highest scoring blue ribbon winner earning 95+ in Section A, Classes 1, 2, and 3. Designer has choice of plant materials and other components. Winner determined by the assigned panel(s). It is a rosette of purple ribbons.
2. **Petite Award (HB p. 43)** may be offered and awarded to the highest scoring blue ribbon winner earning 95+ in Section B, Classes 4, 5, and 6. Designer has choice of plant material and other components. Winner determined by the assigned panel(s). It is a small rosette of blue and white ribbons.
3. **Table Artistry Award (HB p. 43)** may be offered and awarded the highest scoring blue ribbon winner earning 95+ in in Section C, Classes 7, 8, and 9. Designer has choice of plant materials. Winner determined by the assigned panel(s). It is a rosette of burgundy ribbons.
4. **Club Competition Award (HB p. 43)** may be offered and awarded in Section D, Class 10. Winner determined by the assigned panel(s). It is a rosette of light blue ribbons.

### BOTANICAL ARTS TOP EXHIBITOR AWARDS – SECTION AWARDS

1. **Botanical Arts Horticulture Award (HB p. 44)** may be offered and awarded to the highest scoring blue ribbon winner earning 95+ in Section A, Classes 1, 2, and 3. Winner determined by the assigned panel(s). It is a rosette of light brown ribbons.

## GENERAL RULES

2. **Botanical Arts Artistic Crafts Award (HB p. 44)** may be offered and awarded to the highest scoring blue ribbon winner earning 95+ in in Section B, Classes 4, 5, and 6. Winner determined by the assigned panel(s). It is a rosette of navy blue ribbons.

## LOCAL AND SPECIAL AWARDS

1. **Judges' Choice Award** may be offered and awarded to the finest exhibit in the entire Design Division as determined by ballots from all judges. Winning exhibit must have won a section Top Exhibitor Award in the Design Division. It is a rosette of brown/teal ribbons.
2. **Rose Award** may be offered and awarded to the top specimen in Section D scoring 95+ points. Winner determined by the assigned panel(s). It is a rosette of rainbow color ribbons.
3. **Sweepstakes Award-Design (HB p. 46)** is given to the club winning the most blue ribbons in the Design Division. In case of a tie, red ribbons will be counted. This award may be offered and awarded and is determined by the Tabulation Committee. It is a rosette of green/white ribbons. The Pensacola Interstate Fair, Inc., generously offers a cash prize to the top 3 clubs.
4. **Sweepstakes Award-Horticulture (HB p. 46)** is given to the club winning the most blue ribbons in the Horticulture Division. In case of a tie, red ribbons will be counted. This award may be offered and awarded and is determined by the Tabulation Committee. It is a rosette of green/white ribbons. The Pensacola Interstate Fair, Inc., generously offers a cash prize to the top 3 clubs.
5. **Sweepstakes Award-Botanical Arts (HB p. 46)** is given to the club winning the most blue ribbons in the Botanical Arts Division. In case of a tie, red ribbons will be counted. This award may be offered and awarded and is determined by the Tabulation Committee. It is a rosette of green/white ribbons. The Pensacola Interstate Fair, Inc., generously offers a cash prize to the top 3 clubs.
5. **Individual Sweepstakes Award** is given to the individual winning the most blue ribbons in the Horticulture Division. In case of a tie, red ribbons will be counted. This award may be offered and awarded and is determined by the Tabulation Committee. It is a rosette of green/white ribbons.

# DIVISION I - HORTICULTURE

### HORTICULTURE RULES

1. All horticulture specimens must be **fresh plant materials grown by the exhibitor.**
2. All classes are open to amateur gardeners.
3. All entries must be checked by Classification Committee and must **conform to the schedule** regulations. All entries are to be labeled by genus and specific epithet and/or variety or patented/trademarked names. Common name may also be given.
4. Exhibitor may enter more than one specimen per class or subclass if each entry is a different genus, specific epithet, cultivar, variety, type, size, or color.
5. Classification Chairman has the authority to subdivide classes by color, type, cultivar, etc., as necessary. Judges do not subdivide.
6. Clear containers for fresh cut plant materials and beige paper plates for fruits, nuts, and vegetables will be provided by the committee.
7. There should be no foliage below the water line on cut specimens except Gladiolus.
8. Wedging materials, if needed, will be furnished by the committee. No anchoring is allowed.
9. No oiling, dressing of foliage, or wiring on cut specimens or container grown specimens is allowed unless actively growing on the support.
10. Plants with height or width exceeding 30" may be refused by classification; alternative placement may be allowed if space is available. These specimens will not be judged.
11. Cut flowers or cut decorative foliage should be one stem unless otherwise indicated in the schedule.
12. Specific sections and classes in horticulture may have restrictions for entering. Please check the schedule.
13. Reference for horticulture entries will be the *Southern Living Garden Book*.
14. Plants, cut or container grown, must have been in the possession of the exhibitor 90 days, combinations growing together for 6 weeks, arboreal for 6 months, annuals to maturity. (HB p. 55)
15. Specimens that do not conform to schedule regulations will be accepted for display for the edification of the public but will not be judged.

### CONTAINER PLANTS and HANGING BASKETS

1. **Containers for foliage and flowering plants**, preferably of clay or black plastic, **MAY NOT EXCEED 12"** in diameter or height. **Hanging Baskets** may not exceed 18" in diameter or height. Weight limit for all containers is 20 lbs. No double potting. Container-grown exhibits must have been in **the exhibitor's possession for at least 90 days.**
2. No accessories are allowed in containers: no props, sticks, wires, ties, etc., unless actively growing on the support. If the plant naturally vines, a trellis is permitted.
3. Hydroponically grown exhibits will not be accepted.

**All horticulture specimens will be received October 19 from 8:00 to 11:00 a.m.**

**All entries must be on the classification table by 11:00 AM.**

**NO LATE ENTRIES WILL BE ACCEPTED.**

#### SECTION A. CUT FLOWERS FROM ANNUALS “Botanical Gardens”

Enter one stem or spray unless otherwise noted. Foliage SHOULD be included ONLY IF it grows on the stem. Stem should be in good proportion to bloom. **Specimen should be cut as long as possible (preferably 8”-10”) but NO LONGER than 24”.**

Each collection and/or display must consist of a minimum of 5 different cut specimens exhibited in individual containers, 5 different container-grown plants exhibited in individual containers, or 5 specimens, sets of fruits, vegetables or nuts exhibited on plates, mats, etc.

- a. one family;
- b. plants with like characteristics;
- c. different types or species within a genus;
- d. different cultivars within a genus or species;
- e. five different annuals, biennials, perennials, or sets of fruits, vegetables, or nuts;
- f. five different cut branches. (HB p. 60)

## DESIGN RULES

1. **All entries received 8:00 – 11:00 a.m. Wednesday, October 19**
  - a. ONLY exhibitors and show committee will be allowed in the show area at this time.
  - b. **RESERVATIONS are necessary** for all design classes. (gvjogan@panhandle.rr.com)
  - c. Design classes consist of four (4) entries each.
  - d. Exhibitor is limited to one (1) entry per class but may enter as many classes as desired.
  - e. Entry cards will be filled out and placed by the Reservation Chairman.
  - f. All entries **MUST BE THE WORK OF ONE EXHIBITOR** (exception: Club Competition exhibits or Companion Exhibits) and must be verified for conformance by the Design Conformance Committee **BEFORE** the exhibitor leaves the floor.
  - g. Exhibitors are expected to freshen their exhibits as necessary throughout the show. Access to the building through the back door will be possible on Tuesday, October 25, from 10 am -12 pm, or by special arrangement with show chair.
  - h. If Designer is unable to fulfill her/his assignment, it is Designer's responsibility to find replacement.
  - i. If Designer cannot place design on show day, someone else may put completed design in place, using photo as a guide.
  - j. Designer is on her/his honor that the design being entered has not been previously entered or previously judged in an NGC show.
  - k. The Designer has the freedom to choose Traditional or Creative Style with any Design listed unless restricted by the Schedule.
  
2. **Plant Material**
  - a. All designs must contain some plant material.
  - b. Plant material need not be grown by the exhibitor (unless schedule requires it in specific section/s or classes).
  - c. Plant material must be listed with ***botanically correct*** name on a 3" x 5" card provided by the exhibitor. Classification will assist with naming of plant material upon request.
  - d. Fresh plant material may not ever be treated in any manner. Dried plant material may be treated.
  - e. Contrived flower forms of recognizable plant material are permitted.
  - f. Landscapes or scenes are not permitted.
  
3. **Judging will begin at 1:00 p.m. on Wednesday, October 19.**
  - a. Blue or 90+ ribbon winner's entry card **MUST BE SIGNED BY AN ACCREDITED JUDGE**. Other placed entries need not be signed. Entries **NOT PLACED MUST BE INITIALED** to prove they have been seen by the judging panel.
  - b. Judges will write comments for all entries (except blue ribbon winners) on the back of the plant material card.
  - c. The decision of the judges shall be final. Top awards will be determined by the designated panel of judges who judge in that section. Awards may be withheld if not merited.
  - d. Exhibitors will not be allowed on the floor while judging is in progress.

## DIVISION II - DESIGN

4. **Removal of entries will begin at 8:00 a.m. on Sunday, October 30.** The Staging Committee will remove all entries not picked up by 11:00 a.m. and move them to a safe place so clean up can continue.
5. **Protection of all exhibits** will be carried out as much as possible; however, the show committee cannot be responsible for loss or damage to the exhibitor's property.
6. When a **staging panel** is required in the schedule, it **MUST** be provided by the designer and meet specifications as listed.

#### SECTION A. “Outdoor Adventures”

*Eligible for Designer's Choice Award*

Designer has choice of plant material and other components. If fresh plant material is used, it must be replaced if wilted before the show ends.

Class 1. **“Our National Parks”** (Exhibitor must state which park.)

A Still Life Design (HB p. 76) exploring the attractions of a particular national park, staged on a 36” W x 30” D section of a 30”H table draped in black. A 36” trifold niche provided by exhibitor is required. Underlay provided by exhibitor is permitted.

Class 2. **“Searching for Shells”**

A Low-Profile Design featuring seashells staged on a cream-colored coffee table 36 ½” long x 18 ½” wide x 15” high. Underlay provided by exhibitor is permitted.

Class 3. **“Up and Away”**

A Creative Line Design representing the beauties of the great outdoors at higher elevations staged in a 36”W x 30”D section of a 30”H table draped in black. A 36” trifold niche provided by exhibitor is required. Underlay provided by exhibitor is permitted.

#### SECTION B. “Outdoor Sports”

*Eligible for the Petite Award*

Class 4. **“Par 3”**

An 8” Creative Design exploring the outdoor recreation of golf, staged on a 15” high wooden pedestal with a 9” square top provided by the committee, placed on a 30”H table draped in black.



## **DIVISION II - DESIGN**

### **Class 5. “I’ve Got a Bite!”**

A 12” Creative Design on the theme of fishing, staged on an acrylic riser measuring 12” in diameter and 12” high provided by the committee, placed on a 30” high table draped in black.

### **Class 6. “Play Ball”**

A Creative Design suggesting any of various ball sports played outdoors hanging inside a 12” black hoop provided by the committee, staged at eye level. Hoops available for pick-up at the Garden Center during business hours.

## **SECTION C. “Outdoor Dining”**

*Eligible for Table Artistry Award*

Designer has choice of plant material. If fresh plant material is used, it must be replaced if wilted before the show ends.

### **Class 7. “Seafood Festival”**

A Tray for One (HB p. 76), provided by the exhibitor, designed to suggest alfresco luncheon dining featuring the fruits of the sea. Tray must be no larger than 16” x 14” and will be placed on one-fourth of a 60” round table draped in black.

### **Class 8. “Boardwalk Café”**

A Functional Table for Two (HB p. 76), designed to suggest being served an alfresco luncheon at a charming boardwalk café. Staged on a 36” square card table, provided and draped in black by the committee. Designer may over-drape 8” to 12” if desired.

### **Class 9. “Campfire Cookout”**

An Exhibition Table (HB p. 76) designed to suggest dinner cooked on an open fire and served alfresco, incorporating a white frame 34”H x 30”W x 6”D with a 12”H x 15”W x 6”D shelf and a 12”H x 10”W x 6”D shelf in opposite corners, provided by the committee. Design will be placed on a 36”W x 30”D section of a 30”H table draped in black and shown against a beige wall. Staging panel optional, to be provided by designer. Frame may be picked up at the Garden Center during business hours.

## **SECTION D. “Outdoor Group Gathering” Club Competition**

*Eligible for Club Competition Award*

### **Class 10. “Celebration on the Lawn”**

A Buffet Table for Four or More (HB p. 76) appropriate for an alfresco group gathering celebrating an occasion specified by the exhibitor, placed on a 6’L x 30”D x 30”H table draped to the floor in black. Underlay may be used, extending no more than 12” over edge of table, to be provided by exhibitor.

##### BOTANICAL ARTS GENERAL RULES

1. All Botanical Arts Horticulture and Artistic Crafts exhibits must contain some plant material.
2. No artificial plant material is permitted in any exhibit.
3. The Scales of Points for judging Botanical Arts Horticulture, Design, Artistic Crafts, and Photography are listed in Chapters 11 and 14 of the *Handbook for Flower Shows*.

##### GARDENS AND WINDOW BOXES

1. The GENERAL RULES OF THE SHOW shall apply.
2. **RESERVATIONS must be made to exhibit gardens and window boxes.** Exhibitors of fairy gardens and window boxes pre-register with Gina Jogan, 850-587-2621 or [gvjogan@panhandle.rr.com](mailto:gvjogan@panhandle.rr.com).
3. Judging will begin at 1:00 PM on Wednesday, October 19, 2020.
4. No artificial turf (Astro-turf) allowed.
5. Fairy gardens and window boxes are judged by

6. All types of accessories are permitted in fairy gardens (HB p. 92).
7. Emphasis in fairy garden is not necessarily on plant material, but some live plant material/s must be included.
8. Fairy garden and window box specimens must be correctly and clearly labeled with the current scientific designation and in a manner to easily identify the specimen's location, either with a single chart or individual placards.
9. Container-grown specimens must have been grown by exhibitor for at least 6 weeks.

##### BOTANICAL ARTS HORTICULTURE OTHER THAN GARDENS (HB p. 91-92)

1. All specimens must be preserved by exhibitor. Purchased specimens are prohibited.
2. All entries must be checked by Classification Committee and conform to the schedule regulations. All entries are to be labeled by genus and specific epithet and/or variety or patented/trademarked names.

## DIVISION III – BOTANICAL ARTS

3. May use hairspray or products such as *Super Surface Sealer* to prevent shattering of fragile seed heads, etc. No other embellishments permitted.
4. Judged by **Horticulture Scale of Points** (schedule p. 5).

**Window Box:** A window box 6”H x 36”W x 6”D attached to the bottom of a mock window measuring 40”H x 36”W, staged on half of a eight-foot table draped in black. Window and box will be natural wood color. All potted specimens placed in the box must have been grown by the exhibitor for at least six weeks. Dirt may not be placed directly in window box. Window box/mock window available for pick-up at the Garden Center during business hours.

**Class 4. “Hanging Out”**

A ready-to-wear pair of earrings devised using plant material. Earrings may be created using curved metal hoops or posts. Entries will be staged on cardstock earring boards attached to cream-colored silky fabric draped over acrylic book stands provided by committee and placed on a 12” x 12” section of riser.

**Class 5. “Outside the Box”**

A gift box decorated using plant material. Size not to exceed 10” square and staged on a 12” x 12” section of riser.

**Class 6. “Outside In”**

A piece of driftwood or old wood board decorated with plant material. Entry not to exceed 18” in any direction, and staged by exhibitor on a maximum 20”W section of a 30”D x 30”H table draped in black. Entry may be hanging, angled, standing, or placed flat on table. If hanging or angled, exhibitor must supply the support mechanism(s) for the exhibit.

## **DIVISION IV – EDUCATION**

### **Non-Competitive “Cultivating the Great Outdoors”**

#### **RULES**

1. Entries may be placed beginning at 9:00 AM on Tuesday, October 18 or by arrangement with the flower show chair and **MUST** be completed by 11:00 AM on Wednesday, October 19. Removal begins at 8:00 AM on Sunday, October 30. If your exhibit is not removed by 11:00 AM, the committee will move it to a safe place so that clean-up can be completed.
2. Each exhibit must use a minimum of 18 square feet of surface area, horizontal, vertical, or combination.
3. Exhibits 1-2 will be displayed on a 48”W x 30”D section of a 30”H table draped in black; Exhibit 6 will be given 30’W x10’D floor space.
